ORDER:-

Every year Government of India sanctions Special Central Assistance for the Economic Development of Adi Dravidars towards the implementation of Scheduled Caste Sub Plan (SCSP) in the State. The assistance received is transferred to the Personal Deposit Account of the Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO), for implementing Economic Development Schemes for Scheduled Caste by the TAHDCO and also through various other departments.

2. The Government of India in its letter Dated 20.09.2017 has conveyed the sanction the release of an amount of Rs.17,38,00,000/- for the year 2017-18 as grant-in-aid under the scheme of Special Central Assistance to Scheduled Castes Sub-Plan (SCA to SCSP) for the following specified activities as per the State Annual Action Plan 2017-2018.

3. The Government of India has also stated that Special Central Assistance being additive to the Scheduled Castes Sub Plan of the States/UTs should be used only for specific sector-wise schemes covering SC population as per latest guidelines on the subject.

4. The Government of India has further stated that the State Government shall furnish quarterly progress reports in respect of utilization of Special Central Assistance to the Government of India, Ministry of Social Justice & Empowerment within 15 days after the end of each quarter, in the prescribed proforma and the States /UTs have to ensure the full utilization of funds for the purpose for which it is given. The Government of India has also requested to display the names and details of the assisted beneficiaries under the scheme on the website of State Government / Department dealing with the development of Scheduled Castes.

5. The Government after careful consideration accord sanction to release a sum of Rs.17,38,00,000/- (Rupees Seventeen crore thirty eight lakh only) for the year 2017-18 as grant -in-aid under the scheme of Special Central Assistance to Scheduled Castes Sub-Plan (SCA to SCSP) to TAHDCO for the following schemes as specified by Government of India.

6. The expenditure sanctioned in para 5 above shall be debited to the following Head of Account:-

7. The amount sanctioned in para 5 above shall not be paid in cash but shall be credited to the following head of account by means of an account payee cheque in favour of the Personal Deposits Account of TAHDCO Limited :-

8. The Director of Adi Dravidar Welfare, Chennai -5 is authorized to draw and disburse the amount sanctioned in para 5 above by an Account Payee Cheque in favour of "Personal Deposit Account" of the Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO)

9. The Managing Director, TAHDCO is directed to adjust the unspent balance of grant released in earlier year if any, for the current schemes. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) should ensure that the funds are utilized for the real purpose and to the actual beneficiaries fully without any shortfall or complaints.

10. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) and the Director of Adi Dravidar Welfare are directed to maintain separate accounts for Special Central Assistance funds operated and disbursed by them for the various components separately for every financial year for implementing various Welfare Schemes. The relevant registers for the various disbursements of assistance should be maintained with the complete details of beneficiaries.

11. If any failure is noticed in this regard severe action will be taken against the Officers, who are responsible for such lapses. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) is directed to send the details of expenditure under the Special Central Assistance schemes for each and every month on or before 10th of the succeeding month to the Government.
